

Increases in ADR continue to drive up hotel revenue - concealing decreases in supply and demand



Movement trends have changed, shifting back towards outdoor recreation and away from retail, sit-down restaurants and bars




Resident spend is down, potentially escalating the feedback that retail and bars are less busy




Overnight Visitation is Down; Flathead County Is Pacing Ahead of Others in Glacier Country




Outdoor Recreation Visitation is Up; Other Categories Down



Change in Spend Year-over-Year



Not All Categories Are Impacted The Same


Change in Spend Year-over-Year

Visitor Definition

Zartico defines a visitor as someone who has:

- Have a common evening location <u>outside</u> of the 8 counties in <u>Glacier</u> <u>Country</u>
- Stayed for more than *two hours* in your destination
- Visited at least *one place of impact*

There is no time minimum that a person must stay at a POI to be counted a visitor, but they must meet all three criteria to be counted.
