They specialize in small group business, 15 people or less. Tours are all done in Mercedes Sprinter Vans. They have multiple tours throughout the summer July 9 - October and all of the weekly tours are sold out up until September. October was marked by the government shutdown, which presented some challenges, but hopefully it was a one-time occurrence. He wants to know if he can stretch into springtime and is offering two dates in June, starting on June 20 and June 27. I will put some ideas together for him. He says they can access the entrances without vehicle reservations per the park allowances for road based tours. Just can't take them on GTSR, use the park concessionaires for that. Is thinking of applying for a special use permit and doing dark sky tours to get to take people on the GTSR at night.
